5. After the contest, the laureate member acknowledges AVPA's right to use his information and products within relevant events and training periods, and agrees to join this promotion effort by sending for each awarded oil:
  - a. All the necessary information and pictures to publish a presentation of the product and its producer.
  - b. At least 2 cartons of olive oils in commercial units (25 cl bottles minimum).
6. The laureate member is entitled to show the AVPA distinction on the package of the awarded product, according to the licence provided by AVPA, which shall be signed for the distinction to be used.
